Buildings and Grounds Report

3/2/20 Vestry meeting

- 1. Terra Electric to schedule to put heaters in women's room
- 2. Gus finished sealing above window over the Ark awning.
- 3. Gus has scheduled work on lower Ark window repairs
- 4. The Ark is looking into removing the wooden Ark structure in their main room in order to maximize their space. There are sprinkler system pipes under that structure which will need to be removed. I am going to have Cintas look at it and advise.
- 5. There are 3 blocks of sidewalk by the area where parents park to drop off kids at the Ark which should be replaced. They are buckling and pose a trip hazard. I have contacted a couple of concrete vendors to look at it.
- 6. The Ark has inquired about having that large tree in their playground either cut back or removed altogether. A dead branch blew onto a parent's car and dented the hood. It is not a liability on us or the Ark since it was through an "act of God," but at the very least any dead wood should be cut out of the tree to prevent any branches from falling on someone. I have a call into ProMark to get some pricing and options.
- 7. David Farnsworth pointed out a few items needing attention in the kitchen. First, he would like to see a workday where we can finish up some unfinished items (including labeling cabinets, touching up paint, cleaning the doors, etc.). I am going to have Sheehan Plumbing look at the hot water heater for the double sink as well as to see about having the sink by the dishwasher connected to the booster which heats the dishwasher water itself.

- 8. When it comes time to have the signs worked on, we need to consult with Sarah Farnsworth and have her move certain plants or let us know what can go.
- 9. Sheehan should have quotes for work needed on the steam and water pipes in the rectory and church
- 10. Items to note regarding the stained-glass window proposed project: I have been keeping in touch with The Willet Hauser rep. Technically, we are outside of the window for his original proposal, but he is fairly confident that he might be able to still honor the original costs despite the increase they had this year. He also indicated that the start date would be roughly 5 months from the time we sign the contract.
